## G. Freedom of Information Act (FOIA) – C. Roman reported:

- FOIA provides the public access to certain public records of public bodies; OCC is a public body and
  must abide by FOIA; every OCC employee is responsible for forwarding FOIA requests to the OCC
  FOIA Coordinator; FOIA requests must be in writing (either email or hard copy) from the requester;
  FOIA requires a response in five (5) business days.

### 3. Departmental Presentation:

- A. Counseling N. Kassab and E. Fett reported:
  - Depression screening completed; some student results: 38% feeling depressed, 53% anxiety;25% PTSD. Your role to learn the signs of depression/suicide: repeated absences, disorganization, erratic behavior, unusual violence in papers, and overblown reaction in not receiving an A.
  - Physical signs: change in appearance, fatigue, excessive weight loss/gain, rapid speech, under the influence.
  - Reach out to counseling when you see the signs of depression/suicide in students. Pamphlets from the MAYO Clinic distributed regarding Suicide Grief: Healing after a loved one's suicide.
  - Community Resources for Crisis flyer distributed on suicide, counseling, support groups, short term psychiatric care.

### The current MACRAO Transfer Agreement Requirements

A minimum of 30 semester hours of coursework must be taken at one of Michigan's participating community colleges. The courses needed to satisfy the MACRAO requirements are as follows:

- English Composition. . . . 6 credit hours
- Science and Math.... 8 credit hours Courses must be taken from a minimum of two subject areas. At least one science course must include a laboratory.
- **Social Science.....8 credit hours** Courses must be taken from a minimum of two subject areas.
- **Humanities..... 8 credit hours** Courses must be taken from a minimum of two subject areas.

## **Recommendations for the newly named Michigan Transfer Agreement:**

Fulfill the Michigan Transfer Agreement; students must successfully complete at least 30 credits, with at least a 2.0 in each course. These credits, which will be certified by a Michigan community college, should be met according to the following distributions:

- 1 course in English Composition
- A second course in English Composition or 1 course in Communications
- 1 course in Mathematics from one of three pathways: College Algebra, Statistics, Quantitative Reasoning, Calculus
- 2 courses in Social Sciences (from 2 different disciplines)
- 2 courses in Humanities and Fine Arts (from 2 different disciplines <u>excluding</u> studio art, theatre performance, music performance, and photography)
- 2 courses in Natural Sciences including one with laboratory experience (from 2 disciplines).

The final determination of what will count toward the MTA requirements is currently being drafted within the Registrar's Office.
