2) Acceptance of Agenda:

MOTION: To accept the agenda as written. Seconded, passed.

3) Approval of Minutes:

MOTION: To approve the minutes of March 24, 2011 as written. Seconded, passed.

4) Leadership:

• Chair Mary Ann McGee welcomed those in attendance to the final CAS meeting of the semester. There are two more Senate meetings scheduled this academic year; one in May at Southfield Campus, and one in June at Auburn Hills Campus.

She reported that the Senate reviewed a "Proposal to Re-Charge SOAC and CRC" and changes to the curriculum process at last month's CAS meeting. As a result of the feedback received from the Campus Senates, the processes are still unclear and they will be revisited next academic year so further clarification can be provided. The Senate has not changed the current curriculum process. After the Senate approves the Consent Agenda, the agenda is sent to the Chancellor for final approval. The Chancellor has asked the Vice Chancellor of Academic and Student Affairs to review the curriculum proposals before he signs off on the forms. However, there is a communication piece missing in the process; there needs to be a feedback loop when proposals are not approved by the Vice Chancellor to faculty members initiating the curriculum proposals. There is a meeting scheduled on May 23rd with the Vice Chancellor, Senate Chair, 3 Standing Committee Chairs of the Senate, and others involved in the curriculum process to discuss: curricular process mapping; communication piece; who's a part of the approval process; and roles and responsibilities.

Mary Ann McGee reminded the Senate that only newly elected council members for next academic year can vote in the election.

6) Presentation

• Public Commentary for SSSRT Re-Design Recommendations

Mary Ann McGee asked the Senate to comment on the SSSRT re-design recommendations/process:

- A member of CPC reported that their council reviewed the recommendations one by one, came up with ideas and they are being forwarded to CASSC.
- As part of the process, the various areas were asked to complete questions. One of the questions asked the following: "Explain how your department could function college-wide with:
 - a. A 10, 20, or 30 percent reduction in staff
 - b. A 10, 20, or 30 percent reduction in non-personnel resources." The answers given didn't actually indicate what could be reduced based on the questions that were asked.
- The process ended up creating "wish lists" instead of answering what is really necessary in order to complete your job.
- A lot of the recommendations were self-serving; they were trying to accomplish their mission.
- When CASSC did not approve a recommendation, there was no reason given.

In summary, several comments were made regarding the process but there wasn't any discussion on a specific recommendation(s).

7) Old Business:

• Proposed SLRC/CRC Process

Karen Lee reported that at last month's CAS meeting the campuses were asked to discuss the draft documents outlining the "Proposed SLRC/CRC Process" at their April Campus Senate meetings for adoption/amendments at the April CAS meeting.

Clarification: The recharging of SOAC and CRC is not ready to be voted on today.

MOTION: To adopt the "Proposed SLRC/CRC Process" for next academic year. Seconded, passed.

Report on Feedback re: "General Education Proposals"
 Marilynn Kokoszka reported that the General Education Committee received suggestions from the campuses at Senate Leadership earlier in the month concerning the three Options presented in March for consideration.
 Suggestions included:

- Blend Option 1 (Outcomes) with Option 3 (MACRAO) creating Option A (see "Ad Hoc General Education Committee Report" on distribution table)
- Blend Option 1 (Outcomes) with Option 2 (current Distribution List) creating Option
 B (see "Ad Hoc General Education Committee Report" on distribution table)
- All seemed to dislike the logos
- Another wanted to see schools that we used for our basis (research)

Conclusion:

- That we need to get further reaction
- Sort through the suggestions with a goal of presenting a single option to the Senate.
- To do so we need more people to contribute their ideas to the process.

Marilynn Kokoszka also reported that the ad hoc GE committee is concluding their work unless they are recharged for next academic year. If the committee is to continue, more people are needed to serve.

8) New Business:

Motion from OR Campus re: Bachelor Degrees
 Leslie Roberts presented the following motion on behalf of the OR Campus Senate:

MOTION: To consider removing all prerequisite exemptions currently being granted to bachelor's degree holders.

Discussion followed:

- A motion was passed at Senate a couple of years ago that exempted students with bachelor degrees from taking courses that require pre-requisites. This policy causes problems with: program integrity, academic preparedness and safety.
- HL Campus one of the academic re-design teams made the same recommendation. It is a disaster when someone is enrolled in a culinary course and doesn't understand the safety issues.
- Will the same consideration be granted to "guest students?"
- Because guest students only apply for one semester, they would have to demonstrate they have taken the pre-requisite through their transcripts. This policy would decrease the number of guest students that attend OCC.
- Friendly Amendment: Add "College Guest Students" to the motion for Clarification
- There is a problem in the paralegal program when pre-requisites are exempted. Everyone in that area is in agreement with the motion presented, and Senate is urged to move forward.
- Is there data to support the motion?
- The word "consider" was added to reflect "not demanding."
- Are we talking about this motion within programs?
- A recommendation was made to send to the campuses for further discussion.

MOTION: To discuss the motion from OR Campus re: Bachelor Degrees at the May Campus Senate meetings for adoption/amendments at the May CAS meeting. Seconded, passed.

Mary Ann McGee asked the Campus Senate Chairs to add this topic to their May agenda and consider questions asked, issues, and what kind of data to look at for a policy change.

9) Standing Committees:

- Academic Master Plan/Shawn Dry
 - Shawn Dry reported that CAMP met with IT to review the relationship between Information Technology and strategic and academic planning, and they also met with Facilities representatives to review the relationship between Facilities and strategic and academic planning. A full report will be provided in May that will summarize both conversations.

Curriculum/Mary Kay Lawless

Mary Kay Lawless presented the Consent Agenda:

Mary Kay Lawless reported that the committee just finished their big push to meet the catalog deadline. The Senate thanked the Curriculum Committee and Leanne Nadlicki for all their hard work throughout the year.

Mary Kay Lawless highlighted the "Catalog Change Summary/2011-2012 – College Curriculum/Instruction Committee" (Per College Academic Senate Approval from 10-28-10 through 3-24-11) as follows:

Mary Kay Lawless also presented the draft "Course Waiver Form" for the College Prerequisite of Placement into ENG 1510. The waiver is a fast-track procedure through the College Curriculum Committee and it would be in effect: Fall 2011 until catalog deadline – March 2012.

MOTION: To discuss the draft "Course Waiver Form" at the May Campus Senate meetings for adoption/amendments at the May CAS meeting. Seconded, passed.

Mary Kay Lawless reported that the Curriculum Committee is reviewing the online "Curriculum Handbook." Senate members were encouraged to send comments/suggestions regarding making the handbook more "user friendly" to her.

Additional Curriculum Discussion:

- Mary Kay Lawless verified that the March Consent Agenda was signed by the Vice Chancellor and Chancellor.
- Is rationale submitted when proposals aren't approved by the Vice Chancellor/Chancellor?
- An additional piece needs to be added to the curriculum process to "close the loop."
- Dr. Holcomb reported that new ways of presenting courses and programs will be recommended as part of the ART recommendations.
- Is there a cross-walk? There will be a new plan for the curriculum process presented in the fall.

- Note: The new courses and new certificates of achievement that were listed as "not approved by the Vice Chancellor/Chancellor" have all been approved with the exception of the course CMN-2000 Green Construction Administration which will be imbedded into a current course offered. "Green" will be part of the entire program.
- Curriculum Review Committee /Karen Lee No additional report.
- Student Outcomes Assessment/Robert Lamphear
 - Robert Lamphear reported the following information:
 - Faculty Assessment Day was a success; 166 were in attendance
 Program Assessment Day was also a success; 45 were in attendance

 - reaccreditation process and how it will impact the college.
 - The committee also discussed the "Proposal to Re-Charge SOAC and CRC."

11) Administration:

- Vice Chancellor Holcomb reported the following:
 - AtD (Achieving the Dream) The core teams are working on strategies and how to move forward. The teams consist of individuals across the campuses. The data teams have submitted initial plans to AtD and they have responded to us with reconsiderations. The teams are looking at the following groups and ways our policies have affected them adversely: Developmental Ed; Developmental Math; ESL; High Touch (0-3 weeks) and Special Populations. Our charge is to define student success for these individuals. We are also looking at data sets and how well we are actually serving students. IR analysts have provided data, information and tremendous follow-up. The current initiatives are interrelated with the Strategic Plan.

- Academic Re-design Team (ART) The Campus Presidents and Vice Chancellor have been reviewing the recommendations from the four cornerstones: Health; Technology; BIS/Business/Human Services; and Liberal Arts. The group is working on combining some recommendations that overlap into one recommendation. They are also looking at programs in a manner that will be beneficial to the institution. There is one more 2-hour meeting planned to finalize the recommendations before they are presented to CASSC. The finalized information will be presented in the same format as the SSSRT recommendations. There will be a "comment button" available on Infomart; comments can be made or questions can be asked and they will be forwarded to the next group. The ART recommendations will be ready to be reviewed by Senate at the May meeting. He thanked Sharon Miller and her staff for hosting a reception for the redesign team. Donations for food and giveaways were received for the event.
- Higher Learning Commission (HLC) New policies are coming from the Federal Government regarding the Carnegie Model. The institution will need to define every type of class situation and how we meet Carnegie hours; we will need to be consistent in the way this is applied. More information will be provided when available.
- He encouraged the faculty to "Have a Great Summer!"

- Gordon May reported that he attend FAD and PAD; both events were done really well and he encouraged participation for next year.
- He also announced that Velma Jones was recently awarded a "Distinguished Phi Theta Kappa Advisor Award."

- Mary Ann McGee announced that the ART recommendations will be reviewed at the May CAS meeting. She thanked all those for their hard work and commitment to Senate this year.

Applications of assessment and documentation skills into each therapeutic massage session at the on-site clinic are expected. See the course syllabus for required practical hours. Course / lab fees."

3. MST-2353 Externship III. This is a 2-credit course with a Group "B" Classification (25 students). Prerequisite: MST-2352. Target date for first offering is Winter 2012. Course description:

"This course completes the student's practical experience in therapeutic massage. During this course emphasis will be placed on accumulating a specified number of hours of hands-on experience at pre-arranged, supervised sites. This course is designed to continue the student's experience in the program clinic and affiliate sites. Students will be expected to apply assessment and documentation skills into each therapeutic massage session at the on-site clinic. Critical thinking will be incorporated in designing an appropriate action plan for client treatment. Appropriate therapeutic techniques taught in previous semester courses will be included in each massage session. See the course syllabus for required practical hours. Course / lab fees."
