MINUTES OF THE DALNET ACCESS TASK FORCE

May 25, 1994

Present: J. Bosler (Co-Chair), L. Bugg, E. Condic (Co-Chair), G. Ellis, S. Ellison, S. Homant, J. Murray

I. Interlibrary Loan Statistics

The meeting was called to order by Jerry Bosler at 9:47 am. Bosler presented the ILL statistics indicating that Harper Hospital had not as yet turned in their statistics. Gloria Ellis indicated that these statistics are incomplete as an accurate picture of information transfer between our institutions because it does not reflect borrowing through infopass and reciprocal circulation agreements. Louise Bugg suggested that the statistics be compiled in a grid format showing the total numbers and the net figures between libraries.

II. PacLink/PacLoan

At this time Jerry went over some of the issues regarding PacLoan and PacLink indicating that these most likely are just a step toward greater resource sharing.

Louise indicated that by August 15, LCAT (MSU) and MCAT (U of M) will be on our DALNET system via PacLink. Louise also indicated that there is a possibility that U of M Flint and U of M Dearborn might also be connected. Louise also went over several issues that the Access Committee reviewed, offering the following recommendations:

1. Should the display of LCAT/MCAT be optional on an institution by institution basis? Recommendation, yes.

2. Should existing institution ILL policies/procedures be kept in tact? Recommendation, yes. *U of M/MSU + Dalnet libraries*

3. Should the Access Directory be distributed to U of M and MSU? Recommendation, yes.

OK

4. Should ILL statistics be re-compiled for U of M Dearborn and U of M Flint? Recommendation, yes. *show catalog* *shows MDAS files and mad catalog*

OK

5. Should signs be developed to publicize PacLink? Recommendation, yes.

6. Should other statistics be kept to evaluate the increase of use of our collection as a result of PacLink? Recommendation, yes - use infopass, ILL and reciprocal circulation statistics.

These recommendations were voted on and passed unanimously. Louise will present them to the June 1, DALNET board meeting.

III. PacLoan

Eric Condic reported that Oakland will act as the test site for PacLoan beginning this summer. Eric informed the committee that it will be kept informed on this test and a meeting will be called mid September to go over the emerging policy issues.

Jerry polled the group regarding its current ILL policies. The meeting was adjourned at 11:45 am.
