Chancellor's Cabinet

The Cabinet regularly meets one day each month to discuss *strategic* issues and 1/2-day each month to coordinate *operational* issues.

March 2005 Strategic Meeting Topics

- 1. March Board agenda: Review the draft in preparation for a meeting of the Board's Executive Officers where the agenda is discussed and finalized for distribution according to Board policy and the Open Meetings Act. Leaders: entire Cabinet
- 2. Strategic Planning: Task force charges for 2005 committees were reviewed; co-chairs were finalized; makeup of the individual task forces was considered to ensure the broadest range of participants; the agenda for the Steering Committee meeting was reviewed; the next orientation sessions for new task forces was reviewed; possible combining of task forces with related interests (global issues) was discussed. The flow for forwarding recommendations from task forces was considered and the role of the Steering Committee was addressed. The consensus as that CPC would receive task force recommendations for review and forwarding to the chancellor and the Steering Committee would focus on making process related decisions and the sharing of information among the task forces. Recommendations were received from Task Force # 6.2.
 Leader: Hillberry.
- 3. *HLC Assessment*: A draft of the mid-term report is ready to be reviewed and submitted at the end of March. **Leader**: Keith
- 4. President's Search: A report on the status of the search process for the OR president was provided. 6 candidates were invited; each candidate will participate in an open forum on the OR campus. Leader: Keith
- Safety/Security Report: The quality of the report was acknowledged. Cabinet accepted the report, endorsed it, and turned over its implementation to the Vice Chancellor of Administrative Services. Recommendations will begin to be implemented. Leader: Brantley
- Leadership Oakland: Chancellor's Office will solicit recommendations from the administration and managers with the intention of submitting two names for participation. Leader: Spangler
- Legal Opinions: Clarify which officers and administrators are authorized to seek opinions and
 advice from legal counsel representing the college in order to coordinate the activity and promote
 efficient and cost-effective use of these services. Legal opinions to be held in Chancellor's Office.
 Leader: Rush
