- OCC leaders have the foresight to plan for a future of improved student success in an environment of projected declines in public revenue.








# **OCC** Strengths

- OCC needs to complete work on the integrated College Academic Master Plan (CAMP).

- OCC needs to align campus & college operations, governance, & communications—
   & clarify lines of authority.
- OCC should review its organizational structure to ensure best practice.



- OCC needs to implement program review across all college areas & to create tools to evaluate future program needs.
- OCC needs to review its resource allocation model to be sure that scarce resources are effectively utilized.
- OCC needs a comprehensive review & revision of academic policies & procedures.

- OCC needs to review evaluation & professional development programs to be sure that administrative staff members are operating effectively.
- OCC needs to evaluate & strengthen College Student Services.

- OCC can benefit from strengthening external engagement.
- OCC needs appropriate Board oversight of the College budget process, including monitoring & assessment as well as best practices for awarding of contracts.

#### An Integrated Planning Model

- An educational master plan sets forth the programs
  & services needed in the foreseeable future to improve how well the college meets its mission.
- A strategic plan sets forth what strategies will be implemented in order to support & improve the needed programs & services, along with plans for finding the resources necessary to implement the strategies.

# Informed Planning Drives Decisions

- A program review process requires all programs & services to review their program goals, assess their success in achieving those goals, & propose new or revised goals for the future.
- Resource allocation plans should be tied to student need & data driven outcomes: focusing on such areas as finances (including budgeting), facilities, technology, & human resources.
- Evaluation of the results of implementing plans is a component of a healthy process.

- Enhance data capacity & application.
- Gather information from benchmark colleges.
- Complete work on comprehensive & integrated CAMP.



# Year One ReDesign Tasks

- Clarify lines of authority, reporting, & accountability.
- Recommend best practices for campus & college operations, governance, & communication.
- Review College administrative structure.



## Year One ReDesign Tasks

- Establish program review criteria & tools to evaluate future program needs.
- Conduct comprehensive review & revision of academic policies & procedures.
- Evaluate & recommend strategies to enhance student success.



# Year Two ReDesign Tasks

- Review & update College budget allocation model with a focus on student success.
- Strengthen external engagement to support College.
- Develop performance appraisal system for administrators.

# Year Two ReDesign Tasks

- Develop policies & procedures for Board monitoring & assessment of budget & for awarding of contracts.
- Complete data capacity building & collegewide application of data to strategic & operational decisions to compliment Achieving the Dream & to promote student success.

# Year Two ReDesign Tasks

 Recommend measures for maintaining a balanced budget & continued fiscal health.



#### Implementation

- CBT will work with OCC Leadership & appropriate College groups on solutions & an implementation timeline for recommendations.
- CBT will be committed to the continued success of OCC.



#### **CBT Engagement**

- CBT team leaders will meet with the Chancellor's Cabinet to clarify expectations & determine timelines for actions to be taken.
- CBT team leaders will meet with the College community to answer questions & solicit input.
