4.4.1 Ammunition and Supplies Oakland Police Academy Auburn Hills Campus

The Board of Trustees approved the purchase of ammunition at a cost not to exceed \$84,306 and related supplies at a cost not to exceed \$5,000 from Michigan Police Equipment for a total cost not to exceed \$89,306 for the 2009-2010 fiscal year.

4.4.2 Target System for Police Firing Range Auburn Hills Campus

The Board of Trustees approved the purchase and installation of a target system from Meggitt Training Systems, Inc. at a cost not to exceed \$124,335.

4.4.3 Regulated Waste Management Services Environmental Health & Safety College-Wide

The Board of Trustees approved the use of US Industrial Tech to provide regulated waste management services at a cost not to exceed \$35,000 for the 2009-2010 fiscal year.
