6) Old Business:

"Student-centered" and "learner/learning centered" – No consensus was reached among the campuses regarding the clarification of "student-centered and "learning/learner

centered. However, the Highland Lakes Campus Council developed some language to use as a starting point. The issue will be discussed at the individual sites in May and be returned to the College Senate for discussion in June.

Non Credit Task Force Recommendations – No discussion. Spokesperson was not in attendance.

OCC Flag – The Senate is developing a mechanism for accepting the current OCC flag as the official flag of the College. The topic will be added to the June agenda.

General Education Committee – Committee members include: Dennis Fiems, Mary Kay Lawless, Jim Berry, Ron Spainhour, Dennis Sobol, Patrick O'Connor, and Marilynn Kokoszka. Carol Brown will serve Ex Officio. Patrick O'Connor will call the first meeting. The committee will appoint a chair.

7) New Business:

Prerequisites – Discussion: Faculty must be sure that they want course prerequisites enforced. The Senators were reminded that approximately one year ago, all disciplines were given the opportunity to decide which prerequisites to enforce. The catalog system and the registration system need to be consistent. Therefore, if a prerequisite is changed, the catalog will be updated to reflect that change. Prerequisites can only be changed through the curriculum committee by following the curriculum process.

NOTE: Vice Chancellor Carol Brown will publish the list of prerequisites and determine the date by which prerequisites can be changed.

Motion: To submit the motion that all prerequisites be enforced beginning in Fall 2003 to campuses in May and return to the College Senate in June. Seconded, passed.

Incompletes - Incompletes are administered differently from campus to campus. Some campuses use a form and some do not use a form; some campuses are enforcing strict guidelines and some are not. The Highland Lakes Senate Council is concerned that if any guidelines are currently in use, they should be made available College-Wide.

Feedback on Construction Issues: TMC is interested in what faculty like about their classrooms. Patti Briggs will conduct a survey via e-mail asking for feedback on what the faculty like about their classrooms. It is important that the College Facilities Committee be informed of any recommendations made by individual campuses with regard to construction.

Committee to Review Catalog Changes: Anyone interested in serving on the committee reviewing the catalog change proposals may contact Mary Kay Lawless at extension 2449.

Course Cartridge Checklist – The TMC is asking that campus senates discuss course cartridges; in particular, issues surrounding the technological impact on OCC's servers of supporting numerous course cartridges and, the submission and sign off procedure for course cartridge forms. Server capacity and student access are issues to consider.

NOTE: An inventory needs to be taken of how many classes are currently using course cartridges and, how many disciplines intend to introduce course cartridges into their classrooms.
