I. SCHEDULE OF NOTIS RELEASES

MDAS 1.1 - 9/30/90

includes automatic holdings linkage (using standard #s); improved user interface, utilizing Z39.58 Common Command Language (CCL standards); host controlled printing support for 3163,3164,3151, and PC printers

LMS 5.0 - 1st quarter 1991

includes year end close; global change, MFHD; Online Control File for table changes; purge programs for patron file records and Bill and Fine records.

- 1. OPAC Changes: MHI for the public should be less intimidating than in staff mode; Z39.58 CCL support; user defined brief and long bibliographic displays; a screen building utility; additional help and explain screen support (examples of "explain" are "explain ILL", "explain borrowing priveleges").
- 2. <u>LSYS</u> <u>for online table changes</u>: almost all tables can be changed online (does not include those concerned with database architecture, e.g. processing unit and institution group)

GTO 3.0 -- 4th quarter 1991

Includes OCLC Passport and Prism Support; support of selected CD-ROM databases (should include most CD-Rom products -- will include any that use the MARC export feature)

MDAS 1.2 -- 3rd quarter 1991

Will be compatible with 5.0 Includes search sets; security; downloading capabilities; and continuous print (host directed)

MDAS serves as an information router, it provides unifying architecture and important menuing capabilities

LMS 5.1 -- 4th quarter 1991

Includes location based catalogs (1000's can be defined) and Project Checkmark - serials check-in, including predictive check-in

II. <u>Enhancements</u> - top 5 from balloting

- 1. Location-based searching -- will be in 5.1
- 2. Resequence and delete of copy holdings -- accepted*
- 3. Predective check-in -- will be in 5.1
- 4. Course reserve in OPAC -- accepted*
- 5. File purge 5.0 includes some purges; there will be more in the future

*know it is important, but not on schedule lyet

III. Report Writer

NOTIS thought it was a good idea but customers' feedback prompted NOTIS to "rethink" it. They realized that the product would not be good if it didn't meet user expectations. There is no release date as of yet.
