The Michigan Tax Credit is limited to the smaller of: 50% of your gift, or 20% of the computed tax, or \$200 on a joint return. We have made the assumption that the gift will qualify for 50% credit. If as a result of the tax credit on the Michigan Income Tax you receive a refund, the refund will be taxable income on your Federal Income Tax return.
