The Junior Associates of North Central Christian is the first and only group of its kind in the nation.

It consists of young people who work for the betterment of North Central Christian College. There is no other college in this country that has such an organization of young people helping to support it. We are proud of this fact.

To be of greater assistance to the college, we have set purposes for our association. We have also established requirements for membership and very high standards for an officer of the association.

PURPOSES OF THE JUNIOR ASSOCIATES

1. To unite Christian young people of the North Central area in spiritual fellowship.
2. To help support N.C.C.C. in all her needs.
3. To promote the highest ideals of Christian fellowship, recreation and education.
4. To advertise N.C.C.C. and to interest prospective students.

REQUIREMENTS FOR MEMBERSHIP — must be between 12 and 21 years old, and not attending college.

REQUIREMENTS FOR AN OFFICER — must be a good Christian with clean habits and high moral standards. He or she must not practice dancing, smoking, drinking, etc.

A TYPICAL MEETING OF THE JUNIOR ASSOCIATES

Since any well run association must have regular meetings, the JA constitution provides that the second Friday of every month will be the meeting night. These meetings are held in the cafeteria of N.C.C.C. at 8:00 p.m.

To give you an idea of what we believe in and what we do, the following is a brief description of a typical meeting:

The President of the Junior Associates walks to the microphone and asks for attention to open the meeting. After welcoming the group, which might number from 300 to 350 persons, he introduces the person in charge of the devotional service. This person directs the service which is climaxed by a guest speaker who speaks to us from God's message. After a prayer, the devotional service is ended and the President once again takes the floor.

The President makes announcements of importance to the association, such as the date of a Youth Program which will be held around the Detroit area or perhaps of a party that JA itself is sponsoring. There are also announcements concerning money raising projects. These announcements are followed by the more business-like parts of the meeting, the Secretary's and Treasurer's reports.

The Entertainment Committee Chairman takes charge of the meeting and introduces the entertainers. This is truly a time for having fun. There are singers, actors, and musicians, many of them very talented and entertaining.

After a closing prayer some of the JA members may pay their dues, which incidentally are not compulsory for membership, buy some of the projects that are on sale, or eat some of the refreshments provided free of charge, or visit with their many friends. Then they return home, happy that they came and determined to return next month, with a friend.

JUNIOR ASSOCIATES RAISES FUNDS

Since one of our purposes is to help support N.C.C.C. in all her needs it immediately becomes apparent that money is a necessary factor in our work. Since dues will not pay for all that we would like to do for the college we find that we must use "money making projects" as a means of financing our work.

Junior Associates consists largely of Christians, so we do not wish to participate in any questionable activities. This does not mean that we are not able to raise money efficiently, however. All it means is that we have to consider and really work at some ideas for a project.


Some of the projects that we have engaged in and the approximate amount of money raised by them are as follows: Selling pens, \$2,500; selling sweatshirts, \$400; selling candy, \$200; Junior Associates Fair projects, \$50; Box supper, \$300; Holiday Banquet, \$200; dues, \$300. This makes a total of about \$4,000 raised by J.A. to date and includes only the 1960-1961 years.

We feel that we have been very successful in our efforts to raise money. The selling is all done by J.A. members.

HOW JUNIOR ASSOCIATES USES ITS FUNDS

Junior Associates has financed the college basketball team trip to Philadelphia for the NICE Tournament, with the cheerleaders (N.C.C.C. won this tournament). We have installed a microphone system in the college All-Purpose Building; bought robes for the chorus; helped pay for the boys' dormitory; helped finance the building of a sidewalk on the campus, and bought the cheerleaders' uniforms.


We have done all this, and with the Lord's will, we will continue to do even more. Yes, it is our aim to help North Central Christian College. We are doing it.
