DALNET DATABASE STANDARDS COMMITTEE MEETING

Monday, December 11, 1995

Minutes

Present: C. Audia, R. Dotson, A. Evans (Guest), B. Ho (Chair), H. Ma, A. Pogany, T. Shen, P. Shunn, F. White
Absent: J. Emahiser, D. Roe

The meeting was called to order at 9:30 am at the WSU Science and Engineering Library.

H. Ma reported that Release 5.1.2 will be implemented on December 16, 1995, and detailed some of the features of this release related to the cataloging functions:

- Related Record Index (RRI): DALNET has opted not to implement this portion of the release due to software problems.
- GTO, targeted record overlay: Anaclare Evans did the extensive testing on this feature, and would report in detail.
- 246 field on the MARC record: It has been activated in the tag table. It had some display problems and A. Evans will do more testing.
- OPAC display: Within each XXX fields, the information can be displayed out of MARC tag numerical sequence in LUIS. Most of the 5XX note fields do display in DALNET/LUIS, and the Committee felt that the more important of the note fields are 504 (bibliography), 505 (contents), 520 (summary, abstract, annotation) and 533 (reproduction). H. Ma has asked J. Green to work with the DALNET Screens Committee to solicit their members' input on the public services' preference for field display orders.

A. Evans reported on her findings in testing the GTO Targeted Record Overlay, and distributed instructions on performing the function (attached). She stated that if a heading has been cancelled or changed, then the record would not overlay. The problem records will be listed in the GTO report and the operator must do manual editing. She alerted us to pay close attention to the New and Dropped Headings List for changes.

H. Ma reported that from a NOTIS product demonstration held on December 8 at the Simons Room, Purdy Library, WSU, audience saw that libraries now can store Internet addresses in the MARC record in the 856 fields. With the client/server technology in place, users can point and click to the 856 fields and connect to the WWW resources. A lively discussion followed. Members were amazed by the research resources now available to the online users, but sobered at the same time by the manpower that must be devoted to update all those Internet addresses. (A. Evans reported that Univ. of Michigan has a program to track all the Internet address changes.)

B. Ho reported that at WSU 856 fields from the OCLC records are retained, but no effort is spent on their validation of accuracy. Further, WSU uses the 866 field on the MARC Holdings Record to cite the information if the material is a computer data file.

Finally, B. Ho stated that WSU had made the decision to stay with the current practice of authority record's headings used code for series as "bbc" and not "cbc" (continuing discussion from the previous meeting.). This caused some concern as a couple of the libraries already instituted the change to "cbc" following the last meeting. B. Ho asked that libraries DO NOT make any more changes from their current practice until further discussion can be made.

An agenda item for the DALNET Database Standards Committee is how to handle information that gives an Internet address for an online publication. As you know, paper publications are being superceded by Internet versions, or are being duplicated on the Internet. How do we tell our users in a consistent way? How do we code this information on the MARC record so we can take advantage of future linking fields? Users will be able to just click on these fields and retrieve the information directly from the appropriate Web site.

(Helen saw this demonstrated in the NOTIS WebPAC and WinPAC software.)
