Attached you will find three reports that contain data related to: 1) the number of student credit hours; 2) total student headcount and 3) the number of credits per student for the First Day of Session, Spring 2001. The third report has been added to provide you with a clearer picture of the relationship between the total student headcount and the total number of credit hours. These reports can be summarized with the following main points:

- The total number of student credit hours were 2% above the projections and equates to a 7.3% increase from the previous year at the same point in time.
- The college has seen a 6.5% increase in the total student headcount when compared to the previous year.
- Every year since 1995, the number of credit hours per student has been steadily increasing. Thus, smaller numbers of OCC students are taking more credit hours.








Summary
